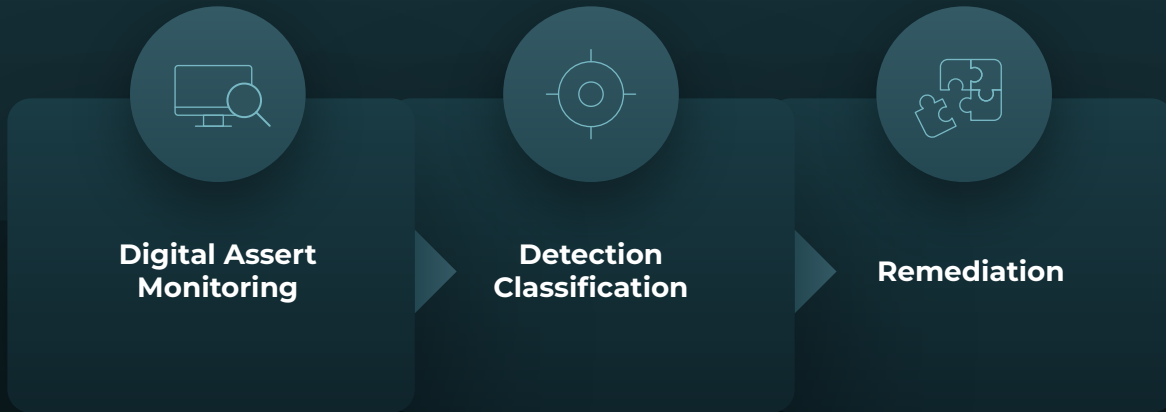

- After-action monitoring services

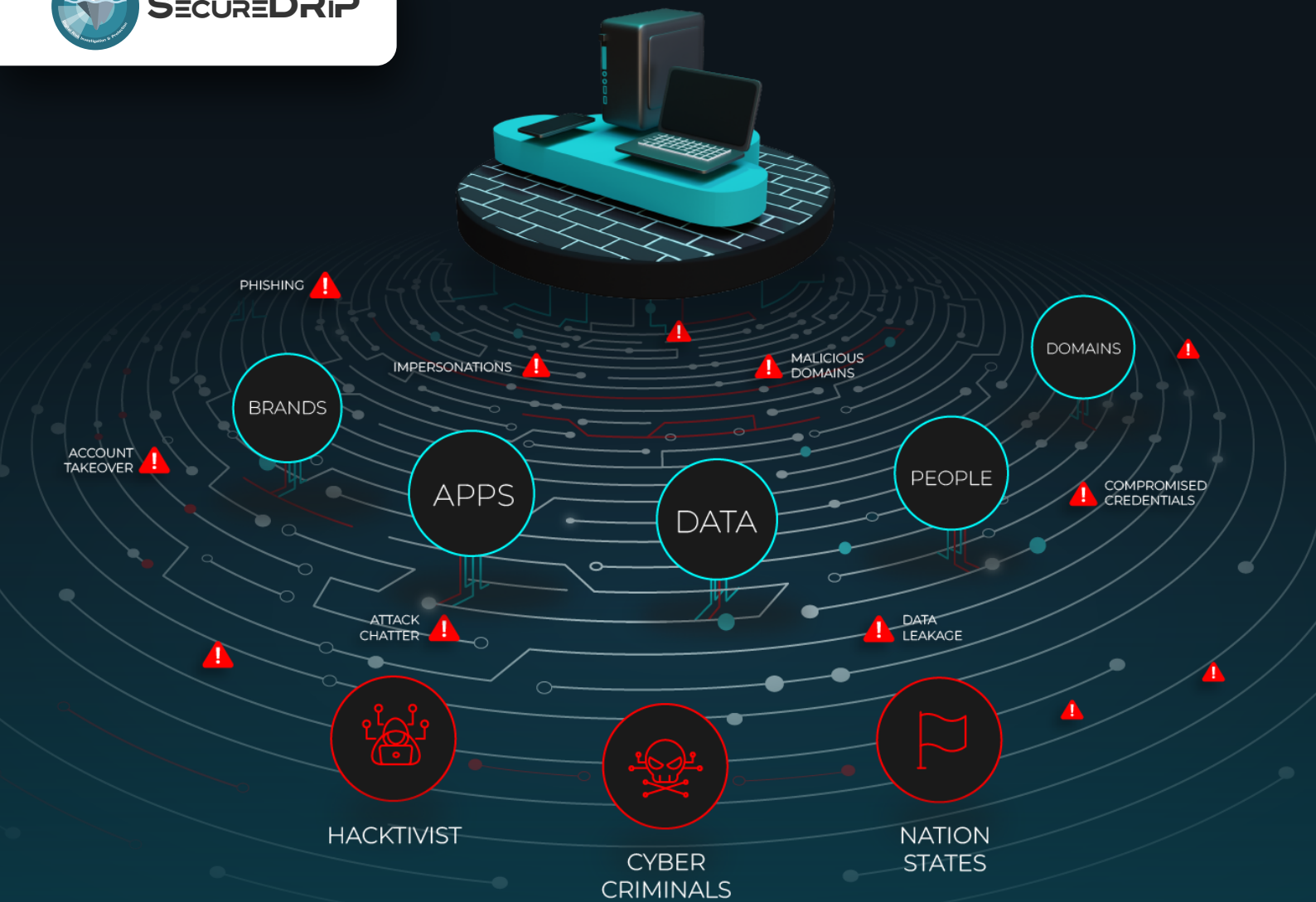
